Cautionary Statement

101.65 (1r) of the Wisconsin States requires municipalities that enforce the Uniform Dwelling Code to provide an owner who applies for a building permit with a statement advising the owner that:

If the owner hires a contractor to perform work under the building permit and the contractor is not bonded or insured as required under s. 101.654 (2) (a), the following consequences might occur:

- (a) The owner may be held liable for any bodily injury to or death of others or for any damage to the property of others that arises out of the work performed under the building permit or that is caused by any negligence by the contractor that occurs in connection with the work performed under the building permit.
- (b) The owner may not be able to collect from the contractor damages for any loss sustained by the owner because of a violation by the contractor of the one- and two- family dwelling code under the building permit or because of any bodily injury to or death of others or damage to the property of others that is caused by any negligence by the contractor that occurs in connection with the work performed under the building permit.

Additional permits may be required: Sanitary Permit- Calumet County 920-849-1442, County land use, Township Zoning, CSM (Certified Survey Map), driveway permit.

Make Check Payable to Town of Chilton and Return application with check. Attach any plans or drawing required with application. Review and approval of plans or drawings can take up to a week. Additional inspections due to work not being up to code or not actually ready for inspection when called will be billed as extra charges incurred.

Fee Schedule:

Town Ordinances and State Statutes require building permits. If you do not apply for a building permit prior to starting work, the Town can double the fees, stop work, and fine you for everyday the work is not in compliance. The permits and follow-up inspections help protect you by ensuring that the work is up to code and safe. Please allow time for your permit to be issued by submitting your completed application and proper paperwork/plans a week prior to the anticipated start of your project.

Examples of projects not requiring a building permit:

- **Changing flooring, carpet, inlaid tile or wood.**
- **Installing sidewalks and garage approaches.**
- **Patios: cement, rock, pavers.**
- **Painting.**
- **Roofing repair or replacement without structural change.**
- **Doors and window replacement without structural change.**
- **Replacing electrical fixtures with the same type of fixture.**
- **Replacing a water heater/furnace.**
- **Replacing plumbing fixtures that do not involve relocating water, drain or vent pipes.**
- **Repairs and remodels costing less than \$4000.00**
